



LEVEL 2 - RETROFIT TRAINING

EnviroGuard Factory Installer Training

DESCRIPTION



Level 2 training is highly recommended when a spill containment kit must be installed for an in-place or on-line battery system. (NOTE: Level 2 certification is required to maintain EnviroGuard's UL Listing on the spill containment system installation.) During this course, best practices will be shared that will minimize installation time, errors and rework. The course has two components: 1) a 1 hour online/on-site training session; and 2) a 6 hour on-site, hands-on where attendees actually perform the measuring, cutting, thermal bonding and sealing the system for a liquid tight installation either during an actual install or "mock" environment. Pre-qualification of retrofit for actual installs is required since some situations require special considerations; we highly recommend consulting with one of our Master Trainer's prior to bidding a retro fit install. Project Management services are available should you require the instructor to assist in the job-walk or be on-site longer for during the installation. Upon successful course completion, attendees will receive a Certificate and Badge.
